The Greater Kansas City Chapter of the FPA is a professional financial planning association, whose mission is to promote the financial planning profession through educating, networking, and mentoring its members and to enhance public awareness of the value of the financial planning process. The FPA of Greater Kansas City awards up to 3 scholarships per year ranging in amounts from \$500 to \$1,000.

Who is eligible?

- Undergraduate and certificate students, enrolled in a program at Kansas State University, Rockhurst University, University of Missouri-Kansas City, University of Missouri-Columbia, Missouri Southern State University, University of Kansas, and University of Central Missouri that meets the education requirement for the CERTIFIED FINANCIAL PLANNER™ Certification Examination.
- One scholarship per year may be awarded to a student enrolled in any undergraduate or certificate program that meets the education requirement for the CERTIFIED FINANCIAL PLANNER™ Certification Examination if the applicant is affiliated with a current FPAGKC member through employment, relation, or otherwise.
- Applicants must have a “B” or better overall grade point average
- Applicants must be at least in their junior year of college

How can I apply?

- Step 1:** Complete a current application (complete all the questions on the application as a failure to do so may disqualify your application from consideration and be sure to sign your application)
- Step 2:** Submit a copy of a transcript from your current school and any schools where you have pursued undergraduate studies
- Step 3:** Submit your application and transcript to the FPA of Greater Kansas City on or before November 11, 2106 to:
